A	1	<p><b>Replace Concrete Pathways</b></p> <p>Inspector Note: Stairs to front entry and porch area show signs of cracking and lifting away from house foundation. Area shows substantial movement which may indicate larger foundation issues.</p> <p>Replace deck in following location: (INSPECTOR DETAIL). Unless otherwise noted materials are to be replaced in-kind. Price to include cost of plan development, review, and approval. If alterations to layout or design are required plans are to be reviewed and approved by client prior to submittal.</p> <ol style="list-style-type: none"> <li>1. Demo and dispose of existing deck.</li> <li>2. Rebuild deck to existing dimensions. Ledger, railing, handrails, stairs, connectors, piers, landings posts, and post bases to be to code. Replace with like materials and PTDF where required/recommended.</li> <li>3. Apply transparent stain or paint where needed depending on homeowner preference.</li> </ol>

A	2	<p><b>Replace Concrete Pathways</b></p> <p>Inspector Note: Side entry concrete steps and landing shows signs of lifting and shifting away from home's foundation.</p> <p>Demo and dispose existing concrete pathway in following locations: (INSPECTOR DETAIL)</p> <p>Properly prep subbase including gravel base layer to industry standards.</p> <p>Pour new pathway to match existing layout. Driveway to be rebar reinforced and with gravel base layer to industry standards.</p>
A	3	<p><b>Install Bathroom Grab Bars</b></p> <p>Install grab bars at toilet and in shower enclosure. Ensure proper framing support.</p>
