Α	1	Shower Pan, Walls, and Fixture					
		Bathroom Allowance: \$2,000.00 Material Allowance includes wall surround, curtain and shower fixtures.					
		Inspector Note: Tub is missing walls, fixtures, and curtain. There may be					
		damage behind the sheetrock and all damaged sheetrock needs to be					
		replaced as well. The window is not installed correctly and will need to be corrected.					
		Demo damaged sheetrock and replace as needed. Window will					
		need to be reinstalled correctly after.					
		2. Install new mixer valve and fixtures.					
		3. Install solid three-piece wall surround, to code and					
		manufacturer's specifications. To include inset shelving or					
		storage accessories per customer preference.

A	2	Replace Toilet Remove and replace existing toilets in both bathrooms with tall ADA compliant dual flush models. Consult client on new fixture. The flange and waste lines may need to be replaced/altered for toilets to be correctly installed.

A	3	Replace Pre-hung Exterior Door Door & Hardware Allowance: (\$1250) Replace total of (1) door in following location(s): (Driveway entry) Inspector Note: Current door is very short and there will need to be modifications to the exterior wall for the new door to fit. Price in all work needed to install a new pre hung door. Replace door and frame and frame with pre-hung, pre-primed exterior grade door to match existing. Make all measurements for accurate install and recommend best solution to work with existing interior and exterior conditions. All new exterior doors must meet the energy performance standards of California's Energy Code. Install replacement type, pre-hung insulated door. Any lites to be dual glazed, low E glass with Argon insulation layer and 0.35 or lower U factor. Install new casing to match existing style. Work will include planning, equipment and material acquisition, area prep and protection, setup and cleanup. Exceptions: Unless noted scope does not include replacement of security doors or related hardware. *Work to be permitted and inspected (if required).
A	4	Replace Window(s) Window Allowance: \$250 Replace total of (1) windows in following locations: (Old window to the right of porch in dining room). Contractor to verify count. Inspector Note: New window should match existing windows as close as possible. Homeowner and contractor to agree on model and color Make all measurements for accurate install and recommend best solution to work with existing interior and exterior conditions. Install new double pane, low E replacement type vinyl window(s) with fusion welded frame and argon insulation layer. All new windows must meet the energy performance standards of California's Energy Code. Unless noted, replacement windows are to fit within existing framed opening. Window type to match existing unless alteration is requested or required by code. Install new exterior and interior casings and touch up paint as needed. Work will include planning, equipment and material acquisition. Exceptions: Unless noted scope does not include replacement of security bars and related hardware. When applicable, existing blinds or drapes to be removed, retained and reinstalled. *Work to be permitted and inspected (if required).

		any other work is required please provide notes in bid
Α	6	Interior Maintenance and Paint
		Inspector Note : There is a ceiling panel in the living room that has come loose and needs to be attached properly. There is a hole in the hallway that is covered by plywood currently, this needs to be patched and painted to match the existing colors.
